### **Guest Presentation by Nelida Andres and Sonia Pruneda-Hernandez**

Our guests gave a presentation on Early Childhood Education Partnership. There are new programs to give credit for prior learning, as well as new scholarships, for students studying Early Childhood Education.

### **Guest Presentation by Guillermo Laya (Collegewide Assessment Centers Director) about Online Assessment**

Finished a pilot project to study Smarter Services, a company that handles online assessment systems, and submitted a request to procurement.

The Assessment Centers are considering a new online system to manage Assessment Center testing.

One system being considered is something called Smart Proctor, which links with Blackboard. Faculty will be able to directly submit exams to the Assessment Center directly through Blackboard, bypassing the current Test Request Form.

They are also researching an Online Assessment service, where students can take tests online, remotely.

### **Liaison Update**

Joel Levine met with Seth Kamen to discuss credit/non-credit bridging. Joel will provide more information at the next meeting.

### **General Discussions**

Motion made to recommend waiving application fees for non-credit students in a credentialing track who are progressing toward a credit program. Motion made by Carol Burbage, seconded by Amanda Stroud. Approved by a vote of 7-1.
