MC Foundation Innovation Grants - Christine Crefton

- Grant Theme: Focus on "Innovations in Connection, Completion, and Community", aiming to enhance the student experience and community engagement.
- Funding: Up to \$40,000 available for projects that demonstrate innovative strategies to improve student connection, retention, and community impact.
- Criteria: Emphasis on collaboration, big ideas, and innovative approaches. Projects should directly benefit students and have measurable outcomes.
- Application Tips: Successful applications should connect to the grant theme, address social justice, equity, inclusion, and demonstrate innovation.
- Grant Proposal Requirements: Proposals must include an abstract, narrative, measurable outcomes, student impact estimation, implementation timeline, need demonstration, and a detailed budget.
- Key Dates: Important deadlines for submission, winner selection, project conclusion, and evaluation submission.
