For our next faculty meeting, I would like to bring up a constituent concern. I would like to know what the College administration is planning to do in order to prepare for the possible impact of Trump's expected immigration policy changes on our undocumented students and families. Immigration allied organizations are sounding the alarm on how this could impact our college campuses, a topic that was recently addressed by an MC organization of which I am a member, called MC ALAS that advocates for Latino student concerns. Members of that organization asked me to present this concern to the Council. I would like the Council to consider making a formal inquiry to our College administration as to what is being done to prepare for these anticipated changes that may be detrimental to the future wellbeing of our undocumented students.

- **College-wide Curriculum Committee (CCC): Harry Singleton**
 - Last meeting was on 11/15/2024
 - The CCC finalized two administrative initiatives to provide consistency in the course catalog:
 - Replaced outcomes starting with “Demonstrate an understanding of ...” with “Demonstrate knowledge of ...” (or other variation with similar descriptiveness).
 - Replaced ranges in credits for numerous programs in the catalog, e.g., 18-20 total credit hours to 18 total credit hours.
 - The deadline is March 7, 2025, to submit revisions to the 2025 catalog (other than simple editorial corrections). Faculty are advised that if there are pending revisions to courses or programs they should contact a CCC CAP or email Harry Singleton.
 - Friday is the last CCC meeting for the Fall 2024 semester. The meeting will be held in person at 2:00 pm in Rockville's SC 152.
